The Yakima Historic Preservation Commission (HPC) is a seven-member body whose purpose is: 1) to encourage the conservation of Yakima's historic resources by initiating and maintaining a register of historic places and reviewing proposed changes to register properties; 2) to raise community awareness of Yakima's history and historic resources; and 3) to serve as Yakima's primary resource in matters of history and preservation planning. The governing authority that established the HPC is Chapter 11.62: Historic Preservation Ordinance, passed by City Council on January 18, 2005.

All members of the Commission must have a demonstrated interest and competence in historic preservation, history, urban planning, or architecture and possess qualities of impartiality and broad judgment.
